REQUIREMENTS FOR BOARDING

1. All animals must be current on all vaccinations to the satisfaction of a veterinarian. Documentation of vaccination record from a veterinarian is required.
2. All animals must be free of communicable diseases, including external parasites (e.g., fleas, ticks, ringworms, etc) or they will be treated at the owner's expense.
3. The Little Lakes Cat Cottage has my permission, after making reasonable attempts to contact myself as well as the emergency contact listed herein, to transport the animal identified on this form if they are sick or injured, to Veterinary Specialists & Emergency Service in Rochester, New York, for treatment at the owner's expense. Unless otherwise specified, all treatment deemed necessary for survival and positive outcome by Veterinary Specialists & Emergency Service will be administered to the named animal at the owner's expense. Further, I agree to indemnify, defend, and hold The Little Lakes Cat Cottage, its employees, members and agents, harmless from and against any and all loss, cost, expense, claim, damage or liability or responsibility arising from such emergency veterinary treatment.
4. The Little Lakes Cat Cottage has/does not have my permission to use images of my pet(s) for the company's website, social media, or marketing materials.
5. I agree to pay all costs and fees related to boarding, parasite treatment, and any emergency veterinary treatments necessary for the welfare of the animal named in this contract for the entire duration of their care with The Little Lakes Cat Cottage.
6. I have provided a copy of a valid form of photo identification for myself, which includes my current valid mailing address, at the time of this agreement.
7. I agree to the arrival and departure date stated on this form, and recognize that if I fail to pick up my animal(s) at the designated pickup date, I am responsible for additional boarding fees, including a \$50 late fee, as well as hourly boarding beginning within 3 hours of the designated pickup time. I also recognize that if I fail to pickup and/or communicate with The Little Lakes Cat Cottage within 5 days of my designated pickup date/time, my animal is considered abandoned.
8. I realize that while staying at The Little Lakes Cat Cottage, my animal will be in indirect contact with other animals, and may come in direct contact with another animal while staying at our facility. I realized, acknowledge, and agree that in the unlikely event my animal is injured by another animal at the facility, I will not hold The Little Lakes Cat Cottage responsible for said injury. Also, if your animal causes injury to another animal, you will be solely responsible for any injury to either/both animals. While all animals coming into The Little Lakes Cat Cottage are required to be vaccinated, animals can still become sick even if they are vaccinated. The Little Lakes Cat Cottage agrees to exercise all due and reasonable care to prevent injury and/or illness to your animal. However, in the event of illness/injury, The Little Lakes Cat Cottage and its agents/employees shall not be held responsible for such injury or illness.
9. The Little Lakes Cat Cottage is not responsible for the loss or damage to any article you brought into/left in the facility with your animal.
10. In signing this agreement and leaving your animal in the care of The Little Lakes Cat Cottage, you represent that you are the rightful and legal owner of the animal named in this agreement., and that all of the information you have provided herein is true.
